On November 12, 2024, the Oregon Institute of Technology (“Oregon Tech”), published Invitation to Bid #2024-05 Athletics Re-Roof (“BID”).

Oregon Tech has found that it is in its interest to amend the BID through the issuance of this Addendum Number One. Except as expressly amended below, all other terms and conditions of the original RFP shall remain unchanged.

3. Unit Price #1 for “Roof Drain Adjustments As Needed (Allowance)” is added as Section 3 of Bid Form.
