INTRODUCTION

Eastern Oregon University Head Start (EOUHS) is issuing this Request for Proposals (RFP) to contract with a licensed Mental Health Consultant to support our Early Head Start and Head Start programs during the 2025–2026 school year.

EOUHS serves children ages 0–5 and their families across rural Eastern Oregon. Our mission is to foster school readiness by supporting the growth and development of children through high-quality, family-centered services.

The selected consultant will provide program-wide mental health consultation, staff training, family engagement support, and consultation on children's individual needs in alignment with the Head Start Program Performance Standards (HSPPS).

AGENCY OVERVIEW

Eastern Oregon University Head Start is a comprehensive early learning program providing:

- Head Start preschool services (children ages 3–5)
- Early Head Start (pregnant women, infants, and toddlers)
- Family services and case management
- Health, nutrition, and disability supports

EOUHS is an integral part of Eastern Oregon University, Oregon's Rural University, committed to serving rural communities with high levels of need, limited access to services, and diverse cultural and socioeconomic backgrounds.

PROPOSAL REQUIREMENTS

Proposals must include:

- Letter of Interest.
- Resume or CV.
- Detailed fee proposal (hourly or flat rate, inclusive of travel and incidental costs).
- Three client references with contact information.
- Completed Bidder/Proposer Tax Laws and Non-Discrimination Certification (Exhibit A).
- Proposer's Federal Tax Identification Number and Secretary of State Corporation Division Business Registry number (or an explanation if not required to be registered in Oregon).

SCOPE OF WORK

The Consultant shall provide services that include, but are not limited to:

- Consult with EOUHS leadership on development of the program's annual mental health services plan, education materials, and policies.
- Provide classroom observations in all centers at least once per year, offering staff technical assistance, education, and support strategies.
- Provide mental health consultation to families upon request, including referral support and resource navigation.
- Deliver at least three staff training sessions per year on identification of child mental health concerns, trauma-informed care, and emergent topics.
- Support teachers and home visitors in strategies for positive behavior support and classroom management.
- Integrate and model practices from Conscious Discipline, EOUHS's evidence-based social emotional and behavior intervention curriculum. All consultation and training should be

- aligned with Conscious Discipline methodology.
- Work with the EOUHS Education Mentor to develop and deliver New Hire Training focused on social-emotional development, trauma-informed practice, and Conscious Discipline implementation.
- Provide classroom- and center-level coaching, as assigned by the EOUHS
 Education Director, to support staff skill-building and fidelity to Conscious
 Discipline and Head Start Program Performance Standards.
- Collaborate with Inclusion Services staff, practice-based coaches, and community partners to support children with behavioral or developmental challenges.
- Provide consultation and education to families on parenting, mental health, and social-emotional wellness.
- Maintain records of consultations and interventions in ChildPlus or other designated systems.
- Attend Leadership meetings as requested(minimum of two per year).
- Report suspected or known child abuse and neglect in compliance with applicable laws.

CONSULTANT QUALIFICATIONS

- Licensed or certified mental health professional in the State of Oregon (documentation required).
- Minimum of three years' experience working with preschool-age children and families.
- Prior experience with Head Start or programs serving similar populations preferred.
- Expertise in Conscious Discipline is required; preference will be given to consultants who are Certified Conscious Discipline Instructors or Master Trainers.
- Ability to provide a minimum of \$750 consulting hours between August 2025 and June 2026.
- Enrolled in the Oregon Central Background Registry.
- Valid Oregon driver's license and ability to travel to multiple sites.

QUESTIONS TO ANSWER

Proposers should respond to the following prompts as part of their proposal -25 points:

- What two factors are most critical to a successful Head Start mental health consultation partnership?
- How will you integrate Conscious Discipline into training, classroom practice, and family engagement to ensure fidelity and measurable outcomes?
- Provide a sample timeline/work plan for the 2025–2026 school year that includes staff trainings, classroom/center coaching cycles, and documentation practices.
- Describe your approach to culturally responsive, trauma-informed care in rural communities.
- Provide an example (de-identified) of a report or plan you have delivered that evaluates child/classroom needs and recommended strategies.

Question Scoring Rubric (per question, 0–5 points)

-5 points (Excellent): Response is comprehensive, specific, and demonstrates clear, measurable strategies or examples directly relevant to Head Start.

- **-4 points (Strong):** Response addresses the question with relevant detail and examples, but may lack some specificity or measurable strategies.
- **-3 points (Adequate):** Response addresses the question generally, but lacks depth, measurable detail, or clear Head Start application.
- **-2 points (Limited):** Response is vague, incomplete, or only partially addresses the question.
- **-1 point (Weak):** Response is minimal, unclear, or not well connected to Head Start needs.
- -0 points: No response or not applicable.

EVALUATION AND SELECTION CRITERIA – TOTAL POINTS 100

- Experience and Expertise-25 points
 - 25 points: 5+ years with Head Start or similar populations; clear knowledge of HSPPS
 - 15 points: 3-4 years of relevant experience; some familiarity with HSPPS
 - 5 points: Less than 3 years, limited knowledge of HSPPS
- Conscious Discipline Expertise 20 points
 - 20 points: Certified Instructor or Master Trainer with documented training experience
 - 15 points: Extensive experience implementing Conscious Discipline but not certified
 - 10 points: General familiarity with Conscious Discipline
- Training & Coaching Capacity 15 points
- 15 points: Documented experience leading staff training, coaching cycles, and new hire onboarding
 - 10 points: Some experience but limited to one area (training or coaching)
 - 5 points: Minimal relevant experience
- Credentials & Qualifications 15 points
 - -15 points: If minimum qualifications met
 - -0: Minimum qualifications not met
- Cost Proposal -10 points
- -10 points (lowest bid receives full points; within 10% of lowest = 7 points; within 20% = 5 points; more than 20% higher = 0 points)
- References 5 points
- 5 points: If 2 are provided2 points: If one is provided0 points: If not provided
- Responses to Questions Section 25 points (as assigned above)
- points TOTAL: 115
